1. Objectives of Collaboration

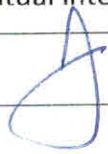
The collaboration aims to:

5. **Recognition:** Each institution is required to provide and exhibit suitable visual (e.g., showcasing logos, information boards, corporate communication media, etc.), written (including social media and correspondence), and verbal recognition (during tours, interviews etc.) whenever the equipment owned by or refurbished by said institution is used for temporary and/or permanent exhibitions and/or demonstrations.

6. **Accountability:** Every partner is expected to conduct themselves with due diligence and professionalism while engaged in collaboration activities. This entails that assets belonging to the collaboration should be utilized solely for the mutual benefit and enhancement of both Sandstone Legacy (Pty) Ltd and the SA Armour Museum as a Department of Defence entity.

7. **Duration and Termination:** This Collaboration Agreement shall commence on the signed date of this document and shall remain in effect until terminated by either party upon three month written notice. Termination shall not affect any ongoing collaborative projects or obligations incurred prior to termination.

8. **Amendments:** Any amendments or modifications to this Collaboration Agreement must be made in writing and signed by authorized representatives of both institutions.
